Dear Director Comey:

We are writing you in regards to Attorney General Jeff Sessions' representations to the Senate Judiciary Committee, both at his confirmation hearing and subsequent to it.

In a written question after the hearing, Senator Leahy asked him:

Several of the President-Elect's nominees or senior advisers have Russian ties. Have you been in contact with anyone connected to any part of the Russian government about the 2016 election, either before or after election day?

Under oath, Attorney General Sessions responded with an unequivocal "No," and provided no further explanation.

During his confirmation hearing on January 10, 2017, Senator Franken also asked him, "if there is any evidence that anyone affiliated with the Trump campaign communicated with the Russian government in the course of this campaign, what will you do?" Rather than respond to the question asked, he instead testified that "[he has] been called a surrogate a time or two in that campaign and [he] did not have communications with the Russians."

On March 1, 2017, the Washington Post reported that Attorney General Sessions had at least two meetings with the Russian ambassador during the 2016 elections.¹ According to the report, then-Senator Sessions had a private meeting in

his personal office with the Russian ambassador on September 8, 2016, and they also had a conversation following an event at the Republican National Convention in July 2016. Following this revelation, the Attorney General issued a statement that claimed he "never met with any Russian officials to discuss issues of the campaign. I have no idea what this allegation is about. It is false."

The Attorney General then confirmed he had met with the Russian ambassador on these two occasions during a press conference on March 2, 2017, during which he said the September meeting took place "in campaign season, but [he did not] recall any political conversations."² He also claimed that he "[did not] remember a lot of [the conversation]." The Attorney General later confirmed both meetings in a letter to the Judiciary Committee on March 6, 2017.

Given his own admissions regarding contacts with the Russian ambassador, including at the Republican National Convention, and particularly in light of his description of his lack of recollection of what was said during the conversations, Attorney General Sessions' written testimony to Senator Leahy appears to be discernably false. His testimony to Senator Franken also appears to be unequivocally false.

We are concerned by Attorney General Sessions' lack of candor to the Committee and his failure thus far to accept responsibility for testimony that could be construed as perjury. We are also disturbed that the Attorney General has not been forthcoming about his contacts with the Russian ambassador since he was forced to disclose the two meetings following press reports. The press has now reported that there was a third undisclosed instance in which the Attorney General may have had contact with the Russian ambassador during the 2016 elections, which occurred at a small, private campaign event in April 2016 with then-candidate Trump in attendance.³

In light of Attorney General Sessions' failure to provide truthful and complete responses to the Judiciary Committee – in his sworn testimony, in his explanation for his false statements, and in his subsequent March 6 letter purporting to provide "supplemental" testimony – we ask that you investigate all contacts the Russian ambassador, or any other Russian officials, may have had with Attorney General

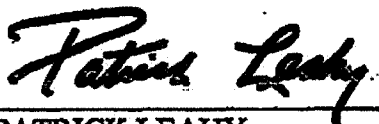

Sessions or with his staff, and whether any laws were broken in the course of those contacts or in any subsequent discussion of whether they occurred. We also request that you brief us on the results of that investigation.

Dear Chairman Grassley and Ranking Member Feinstein:

I write to supplement my January 10, 2017, testimony before the Committee.

During my confirmation hearing, Senator Franken asked the following question:

OK. CNN has just published a story and I'm telling you this about a news story that's just been published. I'm not expecting you to know whether or not it's true or not. But CNN just published a story alleging that the intelligence community provided documents to the president-elect last week that included information that quote, "Russian operatives claimed to have compromising personal and financial information about Mr. Trump." These documents also allegedly say quote, "There was a *continuing exchange of information* during the campaign between Trump's surrogates and intermediaries for the Russian government." [Emphasis added]

Now, again, I'm telling you this as it's coming out, so you know. But, if it's true, it's obviously extremely serious and if there is any

evidence that anyone affiliated with the Trump campaign communicated with the Russian government in the course of this campaign, what will you do?

I responded: "Senator Franken, I'm not aware of any of those activities. I have been called a surrogate at a time or two in that campaign and I didn't have -- did not have communications with the Russians, and I'm unable to comment on it."

My answer was correct. As I noted in my public statement on March 2, 2017, I was surprised by the allegations in the question, which I had not heard before. I answered the question, which asked about a "continuing exchange of information during the campaign between Trump's surrogates and intermediaries for the Russian government," honestly. I did not mention communications I had had with the Russian Ambassador over the years because the question did not ask about them.

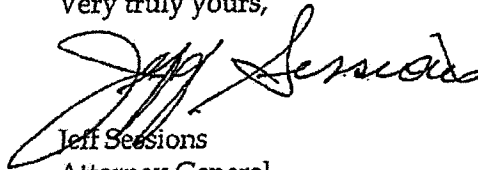
As I discussed publicly on March 2, 2017, I spoke briefly to the Russian Ambassador at the Republican National Convention in Cleveland, Ohio, in July 2016. This was at the conclusion of a speech I had made, when I also met and spoke with other ambassadors. In September 2016, I met with the Russian Ambassador at my Senate office in the presence of members of my professional Senate staff. I do not recall any discussions with the Russian Ambassador, or any other representative of the Russian government, regarding the political campaign on these occasions or any other occasion.

The Judiciary Committee received a letter dated March 3, 2017, from Committee Democrats that asks other questions. The letter asks why I did not supplement the record to note any contact with the Russian Ambassador before its disclosure. Having considered my answer responsive, and no one having suggested otherwise, there was no need for a supplemented answer.

I also promptly made a decision on recusal. I said during the course of my confirmation hearing that if a question arose as to whether I should recuse myself from a particular matter, I would consult with the appropriate ethics officials at the Department in order to make a decision. Within a week of becoming Attorney General, I held the first meeting concerning recusal. And, on February 27, 2017, my staff scheduled a meeting for March 2, 2017. On that date, I met with the relevant officials, and later that day announced my recusal from certain matters. This process and schedule were established before I was made aware of any concern about the accuracy of my testimony before the Committee.

The March 3, 2017, letter also asked why I had not recused myself from "Russian contacts with the Trump transition team and administration." I understand the scope of the recusal as described in the Department's press release would include any such matters. This should not be taken as any evidence of the existence of any such investigation or its scope. Suffice it to say that the scope of my recusal is consistent with the applicable regulations, which I have considered and to which I have adhered.

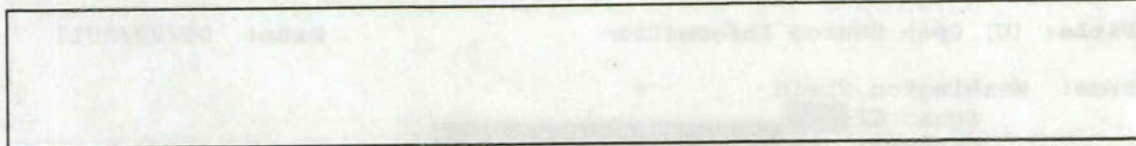

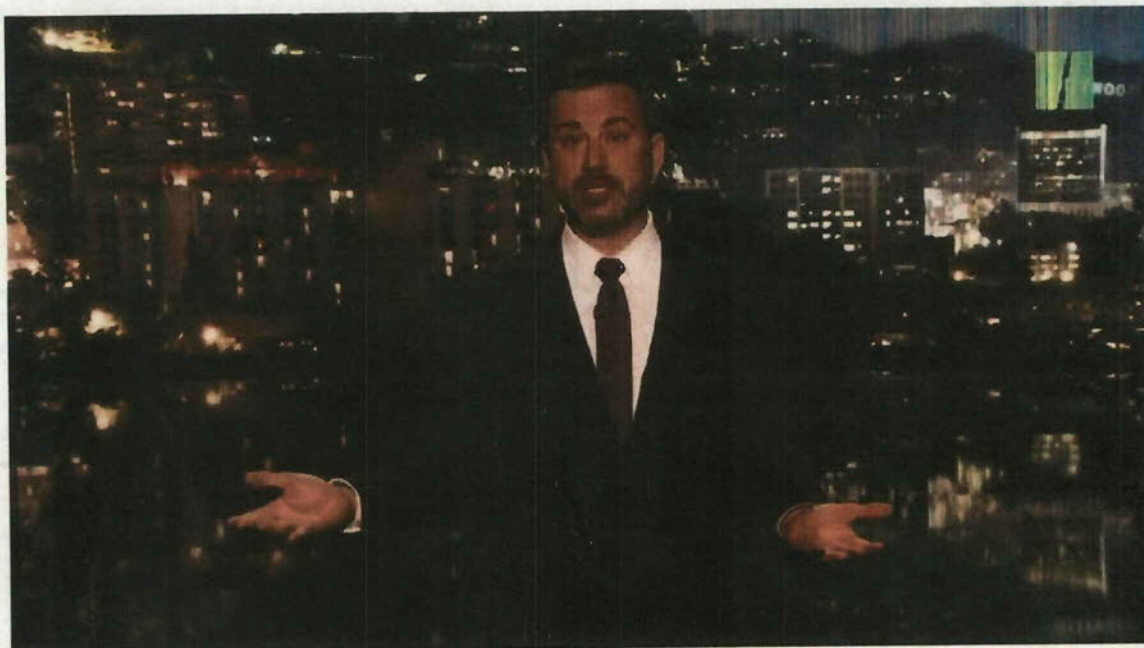

Jeff Sessions Likely Met Russian Ambassador A Third Time

The attorney general initially denied any contact with the Russians, then later admitted to just two meetings.

Attorney General Jeff Sessions was forced to amend prior testimony to Congress this week, acknowledging that contrary to an earlier statement, he'd encountered the Russian ambassador to the United States twice in the last year.

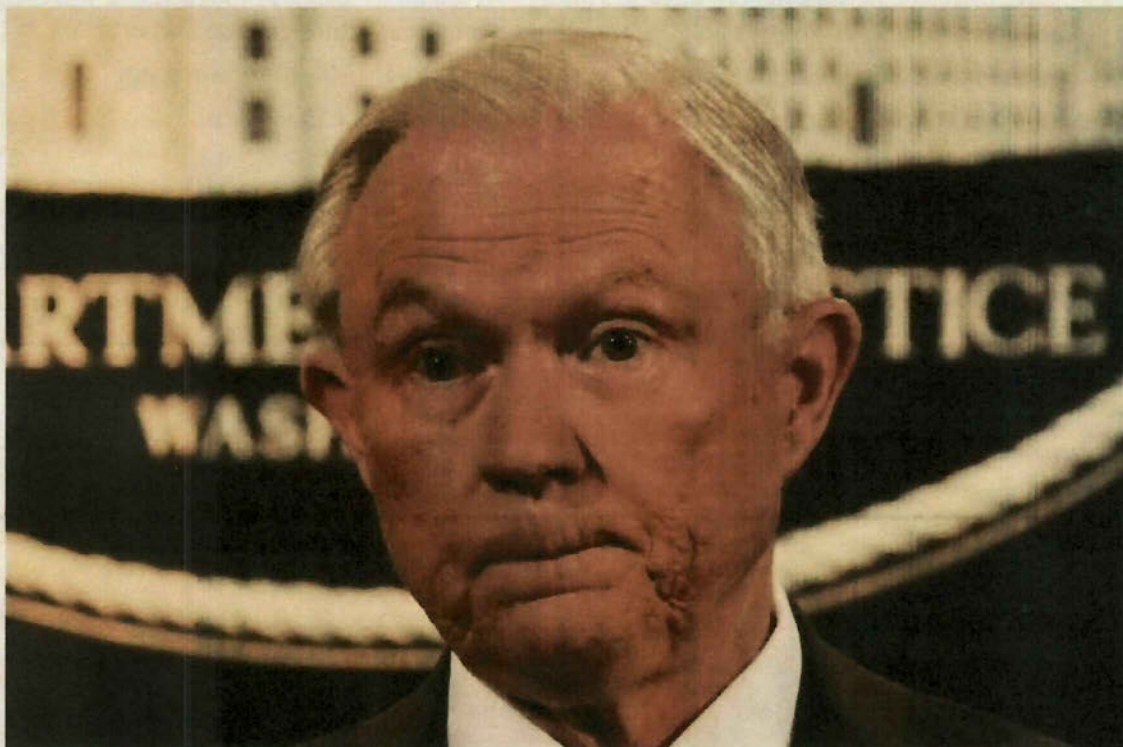

Sessions appears to have left out a third instance in which they crossed paths.

In April of 2016, Sessions attended a VIP reception at a hotel in Washington, D.C., with President Donald Trump and roughly two dozen guests, including four ambassadors. One of them was Russian Ambassador Sergey Kislyak. The cocktail meet-and-greet took place in a private room at the Mayflower Hotel near the White House. Shortly thereafter, Trump delivered a foreign policy speech in the hotel's ballroom, where he called for improved U.S.-Russia relations. Kislyak was seated in the front row.

Though the event was small, it is unclear if Sessions and Kislyak spoke directly, and a spokeswoman for the attorney general did not respond immediately to questions about the event from The Huffington Post. Organizers said the event included a receiving line.

Sessions did not mention the Mayflower event when he was asked during his confirmation hearings about contacts between the presidential campaign and Russian officials. Nor did he put that event in his amended testimony to the Senate Judiciary Committee this week.

The Center for the National Interest, the conservative foreign policy organization that hosted Trump's speech at the Mayflower, invited Kislyak to the reception. An April 2016 story in Politico noted that Sessions also attended the event and was in the Senate Room of the Mayflower, along with "ambassadors."

On Wednesday, the center issued a statement that acknowledged that Kislyak and Sessions both attended the reception but added that it was "not aware of any conversation" between the two.

"However, in a small group setting like this one, we consider it unlikely that anyone could have engaged in a meaningful private conversation without drawing attention from others present," the statement read.

White House spokeswoman Sarah Sanders, meanwhile, said the president was there "for about five minutes" before going to the podium for his speech. There were "several ambassadors" also present, Sanders said, adding that the suggestion that Kislyak and Trump "met or that a meeting took place is disingenuous and absurd."

Last week, Sessions recused himself from any involvement in future Justice Department investigations into Trump campaign contacts with Russia after U.S. intelligence agencies concluded that Russian intelligence agents had meddled in the U.S. election.

Statement Regarding President Trump's April 27, 2016 Foreign Policy Speech at the Center for the National Interest

The *National Interest* and the Center for the National Interest have received many inquiries regarding President Donald Trump's April 27, 2016 foreign policy speech at the White House.

The *National Interest* and the Center for the National Interest have received many inquiries regarding President Donald Trump's April 27, 2016 foreign policy

speech at the Mayflower Hotel. Accordingly, we have decided to release the following statement to share our recollections from that day.

The *National Interest* magazine, which the Center publishes, organized the event to expose Washington's foreign policy community and the American public to the views of a presidential candidate who was then the Republican front-runner. We were very pleased to have this opportunity and saw it as a public service. Because the Center for the National Interest is a non-partisan organization, our hosting the event did not and could not represent an endorsement of Mr. Trump's candidacy. Indeed, just a few weeks later, on May 23, 2016, we presented the Center's annual Distinguished Service Award to Senator Tim Kaine and Senator Pat Roberts at a gala dinner. As is well known, Senator Kaine later became the Democratic Vice Presidential nominee.

As the host, the Center for the National Interest decided whom to invite and then issued the invitations. The Trump campaign did not determine or approve the invitation list. Guests at the event included both Democrats and Republicans, with some among the latter supporting other candidates. Most of the guests were Washington-based foreign policy experts and journalists.

The Center for the National Interest invited Russian Ambassador Sergey Kislyak and several other ambassadors to the speech. We regularly invite ambassadors and other foreign representatives to our events to facilitate dialogue. Ambassador Kislyak was one of four foreign ambassadors who attended the speech that day. We seated all four in the front row during the speech in deference to their diplomatic status. The Trump campaign had nothing to do with the seating arrangement.

The Center for the National Interest extended equal treatment to the four ambassadors attending the event and invited each to a short reception prior to Mr. Trump's speech. The reception included approximately two dozen guests in a

receiving line. The line moved quickly and any conversations with Mr. Trump in that setting were inherently brief and could not be private. Our recollection is that the interaction between Mr. Trump and Ambassador Kislyak was limited to the polite exchange of pleasantries appropriate on such occasions.

We are not aware of any conversation between Ambassador Kislyak and Senator Jeff Sessions at the reception. However, in a small group setting like this one, we consider it unlikely that anyone could have engaged in a meaningful private conversation without drawing attention from others present.

When Mr. Trump finished greeting guests in the receiving line, his Secret Service security detail promptly escorted him to a secure holding area behind the stage while speakers on stage introduced him to the Center's guests and to the media. We did not see any opportunity for Mr. Trump to engage in private conversation with those attending the event during this time.

After Mr. Trump finished speaking, he returned to the secure holding area with the Secret Service and his staff. The Secret Service did not allow anyone lacking necessary official credentials to enter that area. Accordingly, we are not aware of any way in which anyone else outside Mr. Trump's traveling party could have entered this area. Mr. Trump and his party then returned directly to their motorcade with Secret Service escorts and departed from the hotel.

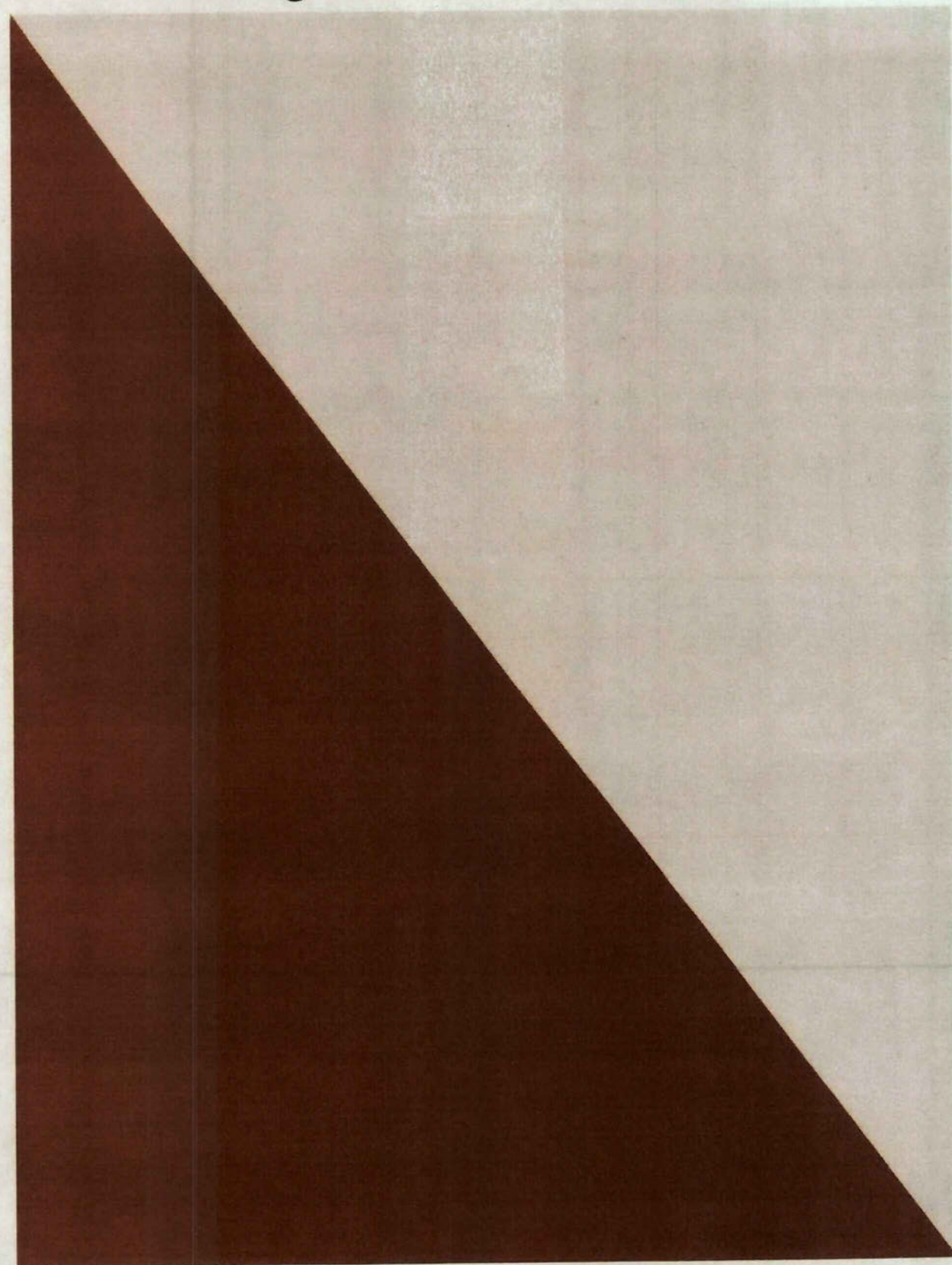
