PURPOSE: To collect a detailed report on Federal funds provided to nonprofit organizations.

Note: BRD will provide guidance to RMOs on how to handle general questions, and where to submit agency responses.

Background: The purpose of this BDR is to collect information on Federal spending provided to certain nonprofit organizations. This information will be used to better understand the scope of funding to these organizations.

Action Required: Attachment A includes a list of nonprofit organizations where OMB is looking to better understand the scope of Federal funding they receive. For these organizations, agencies should report the information included in the provided template (Attachment B).

When responding to this BDR, please note the following:

- Agency responses should include all grants (including grants then provided as subcontracts or subgrants to other entities), cooperative agreements, loans, contracts (including subcontracts), and other monetary awards (awards or subawards) in the total amounts.
- Agencies should report on actual obligations in fiscal years (FYs) 2024, 2025, and estimated obligations in FY 2026 regardless of the fiscal year in which the funds were appropriated.
- Agencies should report on programs and projects for which funds are obligated to these nonprofit organizations even if the provision of this funding is under litigation.

To help agencies respond to this BDR, Attachment B shows all Federal spending reported to USASpending.gov in FYs 2024 and 2025 for these nonprofit organizations by agency. While agencies should use these USASpending.gov reports as a reference, agencies are responsible for validating and updating this data as well as ensuring the entities listed in Attachment A are included in their submission (even if the entity is not shown under their agency in Attachment B).
